To exhibit and display all images, likeness, voice and biographical material on the TTWLA website, to release and distribute materials to all media outlets whether for print, television, internet, as well as social internet sites for all advertisement, promotional and publicity purposes in connection with TTWLA activities.

Participant will not seek any form of compensation, monetary or otherwise, for services performed, traveling or expenses used to perform service, images or likeness, photos, videos or voice recordings, distributed or published as printed material, used or unused, television, internet as well as social internet sites.

**RELEASE OF LIABILITY & INDEMNIFICATION:** Participant is fully aware and acknowledges the activities to perform the service are physical in nature may cause minor to serious injury, known and unknown, including death and damages to personal property. Participant assumes all risk that may arise now and in the future, and agrees to release TTWLA from any and all liability. In the event any claim or legal action is brought by the participant or by a third party against TTWLA, Participant hereby agrees to and does hereby indemnify, save, and hold TTWLA harmless from any and all resultant damages, liabilities, costs, losses and expenses including legal costs and reasonable attorneys' fees.

**ARBITRATION OF DISPUTES & LEGAL COUNSEL, FEES AND COSTS:** All disputes arising out of this Agreement or with respect to the interpretation of the rights of the parties to this Agreement shall be submitted to mediation. In the event of any action, suit, or proceeding arising from or based upon this Agreement brought by either party hereto against the other, each party will seek their counsel of their choice. The prevailing party shall be entitled to recover from the other its attorneys' fees in connection therewith in addition to the costs of such action, suit or proceeding.

**CONDUCT, DRESS AND DISMISSAL :** In an effort to maintain a safe environment for all participants, staff, employees, volunteers, media, sponsors, partners, etc of TTWLA, the venue, or the venues surrounding neighbors or businesses, participant agrees to adhere to the venues' and to TTWLA's guidelines and directives regarding choreography, dress, rehearsals, and behavior before and during service. TTWLA reserves the right to dismiss Participant ("Dismissal" meaning; the participant must cease participation of services and leave the premises immediately.) TTWLA reserves the right to dismiss the participant with or without cause, if TTWLA feels participants actions may endanger anyone, including the participant, the participants use of alcohol or drugs &/or the possession of alcohol or drugs, before, during, or while on the property before or during the lesson. If participant fails to follow the rules and regulations, causes a nuisance or disturbance, commits any illegal or immoral acts. Legal charges may be pressed.
